## National Inventory SHORTAGE Advisory Update #2

Product(s)	Subcutaneous Immunoglobulin (SCIg)
Description	The following is an update to the Amber Advisory originally issued on 2019-05-08. As previously communicated, Canadian Blood Services is currently experiencing short supply of SCIg (Cuvitru®) and this advisory remains in effect.
	Canadian Blood Services has been receiving additional SCIg from multiple suppliers which has improved the current inventory, which is allowing for some increased availability of larger vial sizes from Canadian Blood Services distribution sites. The actions taken by hospitals/clinics have also stabilized demand. As a result, the SCIg current supply situation is gradually improving. We thank stakeholder groups, hospitals and clinics for all their work and continued support during this shortage.
Impact on hospitals	Continued sustained supply of larger vial sizes remains a concern. The NEBMC /provincial programmes are working with stakeholders to develop a strategy to prioritize allocation of larger vials to hospitals/patients. Further communications will be distributed once developed. Until that is finalized, we encourage hospitals to order vial sizes for existing patients per their normal practice.
	Until adequate SCIg supply is restored, we recommend that hospitals continue to follow the previously distributed guidance from communications in May. Hospitals/clinics have been asked to continue to delay transitioning new patients to SCIg, except where it is the only option deemed appropriate for that patient (e.g. patients with urgent clinical need and poor venous access) until further notice.
