



Enhanced wellness measures in effect

In addition to our routine cleaning, infection-control and screening practices, in light of recent developments with COVID-19, we have introduced enhanced cleaning measures, wellness stations and physical distancing measures to better protect anyone who comes through our doors.




Active wellness screening at our building or venue entrances




Donors are seated **2 metres apart** from one another while donating

Increased cleaning frequency of all equipment and surfaces



Laminated donor information pamphlets **are wiped down after each use, or discarded** after each use if they are not laminated



Single-use Ziploc bags are being used to hold blood donation bags

Recent updates to the donor eligibility requirements

Effective Monday, March 30, 2020:

- People who have tested positive for COVID-19 are ineligible to donate until 14 days after their complete recovery. This also includes people who have not been tested for COVID-19, but who have developed a fever and cough within 14 days of having
 - travelled outside of Canada,
 - been in close contact with another person who has tested positive for COVID-19, and
 - been in close contact with a person who has a cough or is experiencing difficulty breathing, and who has travelled outside of Canada in the two weeks before their symptoms started.
- People, other than asymptomatic health care workers and first responders using protective equipment, who have been exposed to the people described above are also temporarily ineligible to the donate.

Blood for Life

- People who have been exposed to symptomatic people who have not been tested and who have not travelled, are eligible provided they do not have symptoms themselves.
- Two new questions are being added to the 'donor questionnaire' asking if they (donors) have had COVID-19 in the last 28 days, or if they have had contact in the last 14 days with a person who has tested positive for COVID-19.
